General comments & level

The attempt at the task was poor. Most of the points were covered. The tone was inappropriate for a letter of this type. The writing lacks paragraphing and discourse markers. There is some range of vocabulary. There are some errors in grammar that negatively affect the writing. The writing exhibits poor word choice.

The lawyer can write clear and somewhat detailed text on subjects related to the lawyer's areas of interest. The lawyer can write less complex documents relating information or defending or opposing a certain position. The lawyer can write letters pointing out important factual details relevant to the issues at hand.

The results of the Test of Writing suggest that the lawyer is at a B2 level for writing.

Overall assessment

Based on all the tests the lawyer's performance suggests that the lawyer is at a **B2 CEFR level**.

Training recommendations

The lawyer is at the most basic functional level for a lawyer working in an international legal environment. The lawyer needs to significantly improve his listening and writing skills. To improve these skills TransLegal recommends that the lawyer take a live PLEAD course (approx. 75 hours) or, in the alternative, a PLEAD Distance Learning Support course (approx. 50 hours). The course selection will depend on the lawyer's schedule. The lawyer would also benefit greatly from the online Legal English 500 course to build key legal vocabulary.

ILEC readiness – to ensure success on the ILEC exam, it is recommended that the lawyer complete the *International Legal English* course (with PLEAD, if increased vocabulary acquisition is deemed important) with an experienced Legal English teacher.
